



Date-Specific Conditions:

Friday, September 14, 2018

1. No vendors on the main path from Public Garden up through to Visitor's Center in order to limit interference with weekday rush-hour pedestrian traffic and weekdays events.
2. No vendors/events on area bordering Frog Pond for same reasons as above.
3. No amplification on either stage in excess of 70 decibels before 5:00 in order to limit interference with ongoing business/schools/etc. around the park.

Conditions Applicable to All Days:

1. No vehicles on Boston Common within one (1) hour prior to Event Hours start time.
2. No dumping of water or other liquids into City's water system.
3. Permittee will provide lighting towers to provide adequate lighting for the following: (1) Vendor Locations; (2) Parkman Bandstand.
4. Site Cleanliness: Permittee is responsible for using and maintaining permitted sections of the Boston Common, specifically including responsibility to remove trash generated by event attendees, and to clean up litter in and around the event boundaries. In order to meet these obligations, Permittee shall provide for at least the following measures:

- i. Place a dumpster at an approved location within the event boundaries for use for emptying event trash barrels.
- ii. Ensure that the dumpster is emptied by 7:00 am on the morning following any event date, and that the dumpster is removed by 7:00 am on Monday, September 17, 2018.
- iii. Provide for at least one trash barrel to be located adjacent to each food vendor that operates within the event boundaries at all times that vendor is operating and for 30 minutes after the vendor

- closes for the day, and that the barrel is emptied as needed throughout the day and at the end of each day.
- iv. Provide at least 100 additional trash barrels (disposable cardboard barrels are acceptable) throughout the event boundaries, including at the edge of any path that leads out from the event boundaries. (Number of barrels on Friday, September 14, 2018 to be agreed upon by Permittee and Parks Department).
  - v. Ensure that all trash barrels are emptied throughout the day of any event so that no barrel is overflowing during the event. Ensure that all barrels are emptied (or removed) after the close of the event on each day.
  - vi. Provide for a crew of at least 5 people to spend at least one hour picking up litter in the vicinity of the event's vendors, stages, and the Frog Pond before 10:00 AM on Saturday.
  - vii. Provide for a crew of at least 5 people to spend at least two hours picking up litter in the vicinity of the event's vendors and stages, and the Frog Pond before 11:00 AM on Sunday.

5. Boston Common is a No Smoking Public Accommodation.

6. Consuming marijuana or marijuana products in a public place is prohibited.

7. Must obtain all other required permits from other city agencies. This permit is not a substitute for permits required by other city agencies.

8. Sound Amplification: Sound amplification permitted during permitted event hours only. All sound amplification shall cease promptly at the end of the permitted Event Hours each day.


9. Use of Vending Tents, Canopies, and Trailers. The Permittee has identified that it wishes to include [#] vendors using tents, canopies, or trailers in its event. Permittee must ensure that its vendors abide by the following conditions. Any vendor that allows any person to use the vendor's tent, canopy, or vehicle in violation of the below-listed conditions is in violation of its right to occupy the Common and shall have its right to remain on the Common under the Permit revoked.

All vendors occupying the Common under the Permit shall be responsible for ensuring that no person smokes tobacco or marijuana inside the area of any vendor's tent or canopy.

No camping.

No distribution of marijuana, as that term is defined in G. L. c. 94G. s. 1.

## WAIVERS

### Special Event Waiver

The City of Boston is not responsible for any accidents or injuries to persons or property resulting from the issuance of this permit. It is recommended that all organizations maintain liability insurance.

The consumption of, or being under the influence of alcoholic beverages is not permitted on Parks property. Immediate revocation of permit and suspension of permit privileges will result.

The consumption of tobacco and all smoking is prohibited from all parks. This includes snuff, chewing tobacco, cigarettes, pipes, cigars and e cigarettes.

The permit bearer is required to remove or place in the proper receptacles any litter left by participants.

Motor vehicles are not allowed on Parks Department property, except where specifically permitted. Violators will be towed.

The City of Boston reserves the right to suspend and/or reschedule assigned events.

Failure to utilize this permit on the designated date and time will result in revocation of this permit.

Permit holder will be held responsible for repair costs.

The permit holder, his/her participants and spectators must abide by all Boston Parks and Recreation Department Rules and Regulations. Any violations of the aforementioned Rules and Regulations will result in the immediate revocation of permit and suspension of permit privileges. I agree to remove any litter generated during the time permitted. I further agree that I will be held responsible for the repair, in a manner approved by the Parks Commissioner, of any damage to City property, which may occur during the utilization of this permit. Violation of this agreement will result in revocation of this permit. Intentionally providing false information on this permit application will result in cancellation of application and may hinder future consideration for applications.

#### OTHER PERMITS

Please note that all components of the event are subject to Boston Parks and Recreation Department approval and may require approval by and/or permits from other City of Boston agencies. Parks Department approval does not constitute permission from other agencies. Events that impact other agencies will be referred to the city-wide Public Events Committee. It is the responsibility of the applicant to secure all necessary City of Boston permits.

#### INSURANCE

Evidence of insurance will be required before final permit approval. Please provide a certificate of insurance which shows a minimum of \$1 million in commercial general liability insurance and a policy endorsement which indemnifies and holds harmless the City of Boston, Boston Parks and Recreation Department and the Boston Parks and Recreation Commission. Some events may require a higher limit of insurance. Additionally, permittee must list the aforementioned parties as additional insureds on their certificate of insurance. Each event is evaluated on its risk exposure. The City of Boston is not responsible for any accidents or damages to persons or property resulting from the issuance of this permit.

#### AFFIDAVIT OF APPLICANT

Everything that I have stated on this application is correct to the best of my knowledge. I have read, understand and agree to abide by the policies and rules and regulations listed on this form as they pertain to the requested usage. By signing this application, the applicant agrees to follow all the rules and regulations.
