It has come to our attention that the proposed development at 305 Brookline Avenue will cast significant shadows on the Emerald Necklace. The dates of concern, which are the dates that the shadow laws for the Common and Garden address, are March 21, June 21, September 21, and December 21. In March there is a large new shadow on the Riverway and parkland from 8am-10am. In June there is small new shadow on the Riverway, and after 6pm there are new shadows on the parkland. In September there is a large area of new shadow on the Riverway and parkland in the morning and again in the evening. In December new shadow is cast on the Riverway and parkland starting at 8:15 and increasing until 10:30, then diminishing by noon.

We urge the City to abide by the guidelines for Longwood Medical Area development that were adhered to for the last Simmons campus proposal, which resulted in protection of nearby parkland while allowing development to occur.

The Friends has created a sunshine model that demonstrates that significant new development is possible Downtown while protecting existing sunshine in the Common and Garden. This model can be applied anywhere in the City, to balance protection and development. As the City inevitably grows, sunshine protection for our irreplaceable greenspaces should be a priority.
